TITLE: DAILY SUBSTITUTE TEACHER

QUALIFICATIONS:

- Current Illinois Professional Educator License or Substitute License
- General knowledge of Common Core Standards, teaching and instruction
- Demonstrated ability to be self-directed, take initiative and manage classroom behaviors
- Strong interpersonal, communication and organizational skills
- Flexible and able to adapt to change with short notice

JOB GOAL: Provide classroom coverage for teachers in various buildings who are absent. Continue classroom learning in accordance with the absent teacher's lesson plans.

REPORTS TO: Building Principal

SUPERVISES: Students

PERFORMANCE RESPONSIBILITIES:

- Instruct students in assigned classroom by using lesson plans provided by absent teacher or developing interactive lessons if none provided.
- Responsible for taking attendance and the well-being and safety of students.
- Ensure classroom and its equipment are in order at the end of the day.
- Keep and leave a status report of lesson plans completed and the group's accomplishments.
- Maintains established routines and procedures of the school and classroom to which he/she is assigned.
- Uses a variety of materials and teaching strategies to stimulate and maximize student learning.
- Utilizes approved instructional material and procedures of the school and classroom in which he/she is assigned to.
- Be a positive role model for the students.
- Manage student behavior in accordance with District 75's policies and procedures.
- Maintains appropriate supervision of students at all times.
- Maintain confidentiality regarding students and staff personal information.
- Other duties as assigned by the Building Administrator.

TECHNICAL

SKILLS: The individual must be proficient in computer usage, word-processing, spreadsheets, presentation and other school-based software.
