Primary Purpose

The Police Investigator is responsible for conducting follow-up investigations of incidents involving AISD students, personnel, and property, assisting in gathering information or evidence for court or administrative use, and preparing detailed synopses of such events.

Qualifications

Education/Certification:

- High School Diploma or GED
- Texas Peace Officer License issued by Texas Commission on Law Enforcement (TCOLE)
- Intermediate Peace Officer Certification; advanced or higher Peach Officer Certification preferred
- Clear and valid Texas driver's license with appropriate insurance coverage

Special Knowledge/Skills:

- Knowledge of the Aldine ISD Student Code of Conduct
- Proficient understanding of the Texas Penal Code, Education Code, Juvenile Law, and processing procedures
- Ability to operate various police-related computer systems
- Strong verbal and written communication skills across various formats, including letters, memos, and emails
- Demonstrated ability to work independently with minimal supervision and effectively as part
 of a team
- Willingness and ability to work long or extended hours, including night assignments on short notice
- Must demonstrate the ability to be available 24 hours a day
- Adherence to Aldine ISD Police Department dress and grooming standards
- · Consistent record of excellent attendance

Experience:

- Minimum of three (3) years of experience as a full-time police officer commissioned with a TCOLE certified police agency
- No sustained IAD or Administrative Complaints in the last one (1) year

Major Responsibilities and Duties

- 1. Support and assist the officers and administration in their efforts of fulfilling the School Boards' goal of providing a safe environment to learn.
- 2. Maintain confidentiality, discretion, and professionalism regarding personal, sensitive, or confidential information—whether verbal, written, or electronic—and do not disclose such information without the express consent or direction of a supervisor

- 3. Exhibit regular and timely attendance at work
- Conduct follow-up investigations of incidents involving AISD students, personnel and/or property
- 5. Assist AISD Administration, staff and officers with the gathering of information or evidence for use in court or administrative purposes
- 6. Assist school staff in emergency situations
- 7. Respond to calls for assistance from AISD Personnel for incidents occurring on and off AISD Property
- 8. Prepare detailed synopsis of events and incidents occurring on/off AISD Property, but involves AISD students or personnel
- 9. Recovery of stolen property belonging to AISD from other law enforcement agencies, pawnshops and/or persons who have possession of property
- 10. Acts as a liaison with other federal, state, county or local agencies
- 11. Conducts surveillance of incidents involving crimes against persons, property and/or public
- 12. Prepares cases of crimes against persons, property and/or the public for presentation to the District Attorney
- 13. Enforces rules and regulations approved by the Board of Education and the school administration
- 14. Appears in court as a witness if summoned
- 15. Performs other job-related duties as assigned

Supervisory Responsibilities

Evaluation

The evaluation of the Police Investigator is a responsibility resting with the Chief of Police, or designee. An evaluation shall be completed in writing at least once during the course of the school year.

Mental Demands/Physical Demands/Environmental Factors

Tools/Equipment Used: District vehicle; possible use of firearms, handcuffs, security equipment, two-way radio, alarm system and other security equipment, fire extinguisher; standard office equipment including computer and peripherals

Posture: Prolonged sitting and standing

Motion: Frequent keyboarding/mouse, occasional driving

Lifting: Moderate lifting and carrying (15–44 pounds)

Environment: Work inside work outside (moderate exposure to sun, heat, cold, and inclement weather), moderate exposure to noise, frequent districtwide travel

Other: Specific hearing and visual requirements; may be subject to adverse and hazardous working conditions including violent and armed confrontations; ability to control sudden violent or extreme physical acts of others and exhibit rapid mental and muscular coordination simultaneously
