Duties and responsibilities:

- Diagnose and prescribe learning and training programs for individual pupils based on student aptitude and interest.
- Provide for individual needs of assigned students.
- cooperate with principal, team leader, staff, and community in implementation of comprehensive instructional and activities programs.
- Other related duties and responsibilities as assigned.

Training and knowledge desired:

- Strong skills and background in instructional methods and strategies.
- Ability to prescribe appropriate instruction and training, use a variety of teaching materials and strategies, plan and carry out instruction to meet varied needs of students.
- Ability to modify instruction to meet varied needs of students within the classroom.
- Manage behavior of students and maintain appropriate balance of control and freedom in the classroom.
- Interest in becoming involved in student activities.
- Ability to establish rapport with students, colleagues, and classified personnel.
- Willingness to benefit from the building supervision and evaluation programs.
- Varied background of abilities, interests, talents, and hobbies.
- Desire to become a part of the faculty.

Requirements:

<u>Working Conditions:</u> Physical Demands – While performing the duties of this job, the employee is regularly required to stand, walk, sit, and reach with hands and arms. Duties may involve significant fine motor dexterity, bending, stooping, and crouching as needed to assist students or operate classroom technology.

Work Environment – Most activities are performed indoors in a classroom setting. The position may require supervision of students in outdoor settings under various weather conditions. The noise level in the work environment is generally

moderate, but may become loud during group activities. The employee has responsibility for the safety and well-being of students and must be able to interact professionally with colleagues, parents, and community members. Potential exposure exists to ordinary infectious diseases carried by students, student bodily fluids, and occasionally to aggressive student behavior.
