INTERNAL/EXTERNAL VACANCY NOTICE **September 26, 2025**

The Churchill County School District is currently accepting applications for the following classified position for the 2025-2026 school year:

POSITION: Paraprofessional Instructional Assistant-Early Childhood Education. – Northside Early Learning Center

DEFINITION: To perform a variety of instructionally related activities by assisting a teacher or teachers in providing intensified learning experiences for students; to provide instructional support services for teachers and students. Due to the young age of students custodial and educational activities can include behavioral management, feeding and lavatory care. Early Childhood personnel are considered to be "at-risk" and are eligible for HBV series.

MINIMUM QUALIFICATIONS: Prior experience working with young children is desired.

LICENSE/EDUCATION/EXPERIENCE: Possession of a high school diploma or the equivalent (GED). Must possess and maintain a valid Nevada Driver's License.

Required Certification and Licenses:

Paraprofessional (highly qualified) requirements:

- Completed at least two (2) years of study at an institution of higher education (in Nevada this equates to 48 semester credits);
- Obtained an associate's (or higher) degree; OR
- Passed a formal State or local academic assessment demonstrating knowledge of, and the ability to assist in instructing, reading, writing, and mathematics (in Nevada the only currently approved test is the ETS Paraprofessional Assessment.)

Possession of or ability to obtain a current Cardiopulmonary Resuscitation (CPR) certificate from the American Heart Association, American Red Cross, or other similar organization within six (6) months of hire. Certification must be maintained for the duration of the assignment.

CURRENT SALARY/BENEFITS: Range 21-Step A \$16.54 through Range 21-Step K \$19.86 an hour (DOE). Scheduled: 166 days per year plus five (5) paid holidays and seven (7) hours per day. Nevada Public Employment Retirement System (PERS), Health Insurance, Sick Leave, and Personal Leave.

FILING PERIOD: All interested applicants must complete a ChurchillCSD application on-line and show that they are qualified for the position requested as described above. Internal applications will be accepted on Friday, September 26, 2025 through midnight on Thursday, October 2, 2025.
