**SUMMARY:** Assists in providing comprehensive health and social services to students and their families and support to the school staff by performing the following duties:

## **ESSENTIAL FUNCTIONS:** (Other duties may be assigned)

- Participates in screening programs under the direct supervision of the Registered Nurse
- Administers first aid and emergency care as defined in the Indiana State Department of Health's First Aid Guidelines for Emergency Care of Illness and Accidents Occurring at School manual
- Reports all significant first aid treatments to the Registered Nurse
- Performs clerical tasks, such as filing, ordering supplies, data entry and telephone communication with parents, staff members, and community agencies
- Assists in maintaining medical and immunization records on students
- · Visits students/families' homes as needed
- Assists in maintaining student attendance
- Delivers, organizes and maintains the first aid supply in every school
- Assists with Cardio-Pulmonary Resuscitation (CPR) instruction as needed
- · Assists in the social service referral process for individual students and/or their families
- Assists in organizing and implementing social service projects such as Thanksgiving baskets, Christmas baskets and toys, summer camps, etc.
- Performs treatments and procedures for individual students/employees as directed by the Registered Nurse
- Maintains confidentiality
- Maintains a regular and reliable level of attendance in order to perform and complete duties as outlined herein
