# GENERAL EDUCATION TEACHER ASSISTANT

Supervisor: Building Administrator Employee Group: Teacher Assistant

Qualifications: Valid Educator License with Stipulations (ELS) or Professional Educator License (PEL)

# **Purpose:**

The position of the General Education Teacher Assistant was established for the purpose of supporting student learning during core instruction. The General Education Teacher Assistant works under the direction of a licensed teacher in the supervision and instructional support of students.

#### **Essential Functions**

- Implements, under the supervision of the assigned teacher, instructional programs and lesson plans and assists students with assignments for the purpose of reinforcing learning concepts initially taught by the licensed teacher.
- Adapts classroom activities, assignments, and/or materials under the direction of licensed staff for the purpose of supporting and reinforcing classroom academic and social emotional learning objectives.
- Collects informal assessment information under the supervision of licensed staff for the purpose of monitoring student progress.
- Communicates and collaborates with teachers and other licensed personnel for the purpose of planning instructional
  activities.
- Monitors individual and/or groups of students in a variety of settings for the purpose of maintaining a safe and positive learning environment.
- Promotes CCSD21 Learner Qualities and student independence for the purpose of improving the quality of student outcomes.
- Responds to emergency situations (i.e., injuries, conflicts, students in crisis, aggression, etc.) for the purpose of resolving immediate safety concerns and/or directing to appropriate personnel for resolution.
- Assists with maintaining accurate records.
- Provides assistance to all students as needed for the purpose of enhancing learning and safety for all.

## **Other Functions:**

- Performs clerical work for the purpose of supporting students and teachers in the classroom.
- Participates in student evaluation, program development, meetings, inservices, and parent conferences as needed for the purpose of acquiring and/or conveying information relative to job functions.
- Demonstrates punctuality and regular attendance for the purpose of ensuring consistency and continuity of instruction for students.
- Performs other related duties as assigned.

## **Job Requirements:**

Specific skill and knowledge-based competencies required to satisfactorily perform the functions of the job include:

- Concepts of grammar and punctuation
- Fluency and clarity in spoken English
- Reading fluency and comprehension
- Basic mathematical skills (i.e., add, subtract, multiply, and divide in all units of measure using whole numbers, common fractions, and decimals; compute rate, ratio, and percent; draw and interpret graphs; money concepts; etc.)
- Safety practices
- Operation of standard office equipment including using pertinent job-related software applications

Specific ability-based competencies required to satisfactorily perform the functions of the job include:

- Effectively presenting information in one-to-one and group situations to students
- Working with emotionally, physically, and/or mentally impaired students

- Maintaining confidentiality
- Maintaining composure under stressful situations
- Maintaining effective decision-making skills
- Communicating tactfully and courteously with diverse groups
- Adapting to changing work priorities
- Working collaboratively as a part of a team
- Applying common sense understanding to carry out instructions

Specific physical ability-based competencies required to satisfactorily perform the functions of the job include:

- Moving up to 50 pounds (pulling, pushing, lifting, carrying)
- Sitting, standing, walking
- Visually supervising students
- Utilizing computer keyboards and screens to enter, retrieve, and transform information or data
