## **JOB SUMMARY:**

The Certified Speech Language Pathologist Assistant is a WA State DOH SLPA-certified position that works independently under the supervision of a licensed Speech Language Pathologist (SLP). This position performs tasks such as conducting speech-language screenings, assisting with direct therapy, documenting progress, communicating with families, providing administrative support and allowing more students access to necessary services. Assists in developing and implementing care plans, strictly following the scope of practice.

## **ESSENTIAL FUNCTIONS AND RESPONSIBILITIES:**

- 1. Provides direct speech, language, and communication therapy to students individually or in small groups, following the specific treatment plans, protocols, and IEP goals as directed by the SLP.
- 2. Conducts direct patient care, including implementing therapy plans, and assisting students with communication and swallowing exercises. Prepares and organizes therapy materials, activities, and visual supports.
- 3. Performs appropriate screenings and assessments for speech-language disorders. Plans, schedules, and coordinates district-wide screening events.
- 4. Assists in programming and troubleshooting Augmentative and Alternative Communication (AAC) devices, assistive technology (AT), and oral motor therapies.
- 5. Records student progress and maintains records.
- 6. Guides the work of paraeducators and other staff by assisting with Speech and Language events, training days, and school-based best practices.
- 7. Provides training to staff in implementation of speech and language therapies and exercises.
- 8. Performs professional SLPA tasks as needed, including emergency care services for both staff and students.
- 9. Adhere to all professional and ethical codes, including the Washington state scope of practice for SLPAs, and all district policies regarding confidentiality (FERPA) and student safety.
- 10. Performs other related duties as assigned.

- Utilizing and maintaining electronic health records.

## Ability to:

- Distinguish between normal and delayed communication development.
- Distinguish between correct and incorrect responses during communication activities.

## **WORKING CONDITIONS**

Exposed to blood or other potentially infectious diseases carried by children. Regularly works in indoor conditions; experiences interruptions and inflexible deadlines; noise level in the work environment is usually moderate, but can be abnormally loud on occasion. Required to effectively handle distraught and/or angry individuals.

## PHYSICAL DEMANDS

Frequently required to sit, move about, hear and speak, and be visually observant of patient behaviors. Frequently required to use fine hand and finger movements (keyboarding); must be able to stoop, crouch, bend, kneel, and stand on feet for extended periods of time; must regularly lift and carry items weighting up to 25 pounds and occasionally lift, restrain, or move up to 100 pounds (with assistance as required)— most typically to intervene in student safety issues. Occasional pushing and/or pulling, climbing and balancing, and reaching required.
