Other desired qualifications include: Strong background in early literacy including phonics and phonemic awareness, ability to differentiate instruction and meet the needs of a wide variety of student abilities and needs; ability to implement PBIS concepts and use RTI protocol; strong classroom management skills; willingness to be a team player; ability to teach to the standards as well as benchmarks and ensure student learning; organized; energetic; willingness to serve on school and district committees; high, realistic expectations for students; love of children; good communication skills; and willingness to continue to grow professionally in a PLC atmosphere.
