JOB DESCRIPTION: The job of water safety instructor is done for the purpose/s of teaching all assigned students how to swim; helping maintain an attractive, sanitary and safe swimming pool/facility for students, staff and public; maintaining required student records; ensuring availability of equipment; and complying with health and safety requirements.

PHYSICAL

REQUIREMENTS: Significant lifting, carrying, pushing, and/or pulling; frequent stooping, kneeling, crouching, and/or crawling; and significant fine finger dexterity. Generally the job requires 10% sitting, 20% walking, and 70% standing. The job is performed under some temperature extremes and a generally hazard free environment.
