Under the direction of the Early Childhood Family Education Coordinator, the Early Childhood Screener is responsible for conducting early childhood screenings for all children ages 3-5, following up with all rescreening appointments and referrals, and for administering age appropriate screenings with children to identify any developmental concerns or related issues.

1.	Administer Health and/or Development screenings for the Early Childhood Screening Program for children ages 3-5 and maintain records of screening.	75%	
2.	Communicates with parent(s)/guardian(s) the results of the screenings, and provides recommendations for resources to address health and parenting concerns.	10%	
3.	Assist in identifying children to be evaluated for special education programming.	10%	
4.	Refer families to community resources and follows up on health-related concerns.	3%	
5.	Assume other responsibilities as requested by the Early Childhood Family Education Coordinator.	2%


