JOB GOAL: To identify social and emotional skill needs in students, and encourage

positive behavior through individual instruction, small group counseling

and consultation to families and school staff.

PERFORMANCE RESPONSIBILITIES:

- Provides individual counseling to students who are experiencing social/emotional/behavioral problems that interfere with their learning or the ability of others to learn. Provides information to families and assists them in accessing long-term or intensive counseling services, as needed.
- Provide lessons that focus on social emotional learning for a variety of ages (pre-K through 6th grade) and present those lessons to whole classrooms.
- 3. Develop lesson planning for small group instruction/classroom lessons that deal with subjects such as social skills, family times, mindfulness, gender issues, emotional regulation, etc.
- 4. Implement SEL programs and activities within designated implementation site(s) utilizing the framework of the Clayton Model and deliver evidence-based practices as outlined in the approved MOU with the NJ Department of Education. Adapt programming for changing circumstances and for virtual use, as needed.

- 5. Participate as requested in preliminary discussions and planning meetings with school contacts (PIRT, I&RS, 504, CST) and support the implementation of evidence-based practices designed to promote positive youth development and academic achievement.
- 6. Maintain detailed records of all services provided utilizing approved Record of Services template provided.
- 7. Assist with scheduling, facilitation and content development of professional development workshops and presentations (both in-person and virtual) for partner school staff, parents/guardians, and community members related to SEL topics.
- 8. Administer surveys and questionnaires to evaluate various aspects of program performance and collaborate with the Walter Rand Institute to use data to guide future programmatic efforts.
- 9. Work closely with schools and partner agencies to establish meaningful connections and a positive culture.
- 10. Always maintain professionalism and positively communicate the mission of the Clayton Model.

PHYSICAL REQUIREMENTS:

The duties of this job require the following physical activities: sitting, standing, reaching, walking, lifting, bending, kneeling, stooping, climbing, pushing, pulling, finger dexterity, carrying, feeling, repetitive motions, speaking, listening, and visual acuity.
