JOB TITLE: RESIDENTIAL OUTDOOR EDUCATOR - Camp Waskowitz

**SUMMARY**: This Residential Outdoor Educator will provide supervision and support for all Waskowitz programs including, but not limited to, Outdoor School, Living History, Reconnecting Ourselves Outdoors to Succeed (ROOTS), Challenge Facilitation, Waskowitz Environmental Leadership & Service (WELS) and. Responsibilities include dining hall supervision, trail and hiking logistics, maintaining records, facilitating student-centered curriculum, promoting student growth, and monitoring the student's safety and well-being while in the district's care. The Outdoor Educator will be assigned a focus area during outdoor school: Science/Environmental Education Curriculum and Instruction or High School Leadership and Instruction. The OE assigned to HS Leadership and Instruction resides in the dormitories during overnight programs. Each program has a different set of weekly hours. When not running program, this is a 6 hour a day position. Additional hours will be added during outdoor school and other programs as needed.

**CONTEXT AND MISSION:** Highline Public Schools serves approximately 18,000 students in the communities of Burien, Des Moines, Normandy Park, SeaTac, and White Center in Washington State. In 2013, parents, students, community members, and staff at all levels of the district came together to develop a strategic plan that reflects our goals and dreams for our students. The plan was updated in 2018 to guide our work through 2023. The plan's promise is that *every student in Highline Public Schools* is *known by name, strength, and need*, and *graduates prepared for the future they choose.* 

The strategic plan is centered on Our Promise. It includes four big goals for Highline students, supported by Our Foundation.

- Equity. We will disrupt institutional biases and end inequitable practices so all students have an equal chance at success.
- Instruction. We will reduce achievement and opportunity gaps by using culturally responsive, inclusive, standards-based instruction.
- Relationships. We will know our students by name, strength and need and have open, two-way communication with students, families and community partners.
- Support. We will increase student success by supporting their social-emotional and academic needs.

WASKOWITZ OUTDOOR SCHOOL: We believe in meeting a child's educational needs beyond curricula and supports traditionally offered by schools. Policies procedures and practices are in place to ensure a physically and emotionally safe experience. We believe that genuine collaboration in the curriculum invites creativity, innovation and long-lasting positive relationships for children with the natural world. Waskowitz partners with nearly ten different school districts to provide quality innovative residential outdoor education. Living in nature, with nature provides opportunities to make connections and develop understandings of how our ecosystems work through interdisciplinary and multidisciplinary approaches. Residential Living and Learning Communities fosters a sense of place, sense of wonder for all that walk through our gates. Waskowitz Outdoor School teaches community and social living skills with intention. Magic happens!

**ESSENTIAL DUTIES AND RESPONSIBILITIES** include the following. This list is meant to be representative, not exhaustive. - Ensures the physical and emotional safety of students during Waskowitz programs: setting the tone for safety and comfort throughout; i.e. regulating shower time with efficiency and locking all doors at night.
- Mentors and builds relationships with students assisting them in personal growth and leadership exploration and development.
- Observes, evaluates and supports high school students teaching, assisting, or counseling during class, cabin and meal times.
- Facilitates innovative and educational focused day and overnight programming. At times will be responsible for overnight coverage.
- Assigned a focus area during outdoor school: Science/EE Curriculum and Instruction <u>or</u> HS Leadership and Instruction. The HS Leadership and Instructional team resides in the dorms during overnight programs.
- Designs and facilitates challenge-based programming.
- Does trail-work, spreads smiles around, assists in the kitchen, office, outside, or wherever/whatever else is needed to ensure the overall success of the program.
- Assists staff, teachers, and students in all camp programs and campfires by singing, dancing, teaching, being silly, having fun, and creating a sense of community that promotes a positive, inclusive environment.
- Other related duties as assigned by the Waskowitz Administrative Team.
