POSITION

Livonia Public Schools is seeking a highly qualified elementary classroom teacher who will be able to develop and sustain academic-focused instruction for his/her students in the elementary grades. The teacher will create an engaging, welcoming, and safe classroom environment which stimulates learning, growth, and development. The teacher will motivate students to develop skills, attitudes, and knowledge needed to provide the primary foundation for future education. The teacher will establish positive and respectful relationships with students, parents, and staff.

DISTRICT OVERVIEW

Livonia Public Schools employs approximately 1,800 staff members, serving approximately 13,200 students pre-K – post secondary. There are 15 elementary schools, 3 middle schools, 3 high schools, 1 career technical center, 1 early childhood center and 1 vocational and transition center in the School District. The annual budget for Livonia Public Schools is \$176 million, with a state funding of \$9,600 per pupil.
