# **Purpose of Position:**

The Instructional Coach is a skilled facilitator of continuous adult learning. The Instructional Coach will support School Town of Munster teachers to develop and implement engaging, learner-centered pedagogies. The Instructional Coach will focus on individual and group professional development that will expand and refine the understanding of research-based effective instruction. The Instructional Coach will provide personalized support that is based on the goals and identified needs of individual teachers.

# Responsibilities and Duties:

- Communicate effectively with members of the school district and leadership staff.
- Communicate and demonstrate research-based instructional practices that result in increased student performance and improved classroom environment.
- Encourage professional growth and provide organized, individual and/or group learning opportunities for teachers.
- Facilitate the intellectual and professional development of teachers.
- Facilitate positive relationships with teachers and administrators.
- Assist teachers in creating materials that are in alignment with curriculum.
- Model support for curriculum software products, and classroom/curriculum related technologies.
- Model support for analyzing student assessment data.
- Model support for classroom motivation and management strategies.
- Coach/Model lessons when applicable.
- Assist with development of district curriculum, instruction and assessments.
- Other duties as assigned by the Assistant Superintendent or building principals.

- Indiana Elementary or Secondary Teaching Licensure, or Reading Specialist Certification
- Experience as elementary or secondary teacher and/or building-district level coach
