TITLE: ATHLETIC TRAINER

QUALIFICATIONS:

- 1. Minimum Bachelor's Degree from accredited college or university.
- 2. Athletic Training certification from BOC (Board of Certification, Inc.).
- 3. NJ Athletic Training State License per N.J.S.A. 45:9-37.35 et seq.
- 4. NJ DOE (Department of Education) certificate per N.J.A.C. 6A:9-13.17.

REPORTS TO: Director of Athletics

JOB GOAL: Provide "Athletic Training Services" to student athletes under the direction of the team

physician or by written referral from a physician, and in accordance to current state

law.

PERFORMANCE RESPONSIBILITIES:

- The Athletic Trainer is required to maintain current certifications for the BOC and NJ state license.
- 2. The Athletic Trainer is responsible for meeting continuing education requirements for BOC, DOE, and NJ state license.
- 3. The Athletic Trainer shall render service or treatment under the direction of a physician's standing orders.
- 4. The Athletic Trainer shall provide preventative measures and emergency care of injuries sustained by student athletes.
- 5. The Athletic Trainer will assess, treat, rehabilitate and recondition injuries sustained by student athletes.
- 6. The Athletic Trainer will be responsible to supervise return to play progression of athletic injures/concussions sustained by student athletes and discharge upon completion.
- 7. The Athletic Trainer will keep coaches aware of participation status of athletes.
- 8. The Athletic Trainer will be responsible for documentation of treatment plan of care and completion of accident reports/school insurance form.
- 9. The Athletic Trainer will be responsible to provide coverage for home events and travel with Varsity Football.
- The Athletic Trainer will be responsible to provide resources for coaches for injury management.

- 11. The Athletic Trainer will communicate with parents, nurses, and administrators in coordinating care for student athletes.
- 12. The Athletic Trainer shall be responsible to work co-operatively with the school nurses and school physician to co-ordinate and administer sport physicals.
- 13. All of this shall be done in accordance to current NJ Administrative Code (Athletic Training Practice Act).
- 14. Perform any additional responsibilities as assigned by the Superintendent and Director of Athletics.

TERMS OF EMPLOYMENT:

Ten month contract. Salary and schedule to be determined by the Board of Education.
