District programs address the special needs of learning-disabled, academically gifted, and artistically talented students.

The Renton School District serves a diverse population; our racial/ethnic data reflects the diverse, vibrant community we serve: African American 15%, American Indian 1%, Asian 25%, White 27%, Latino 23%, Pacific Islander 1% and Multi-Racial 8%. Approximately 2,861 students are bilingual, coming from homes where English is not the first language. Over 90 languages are spoken by our students and families.
