MINIMUM QUALIFICATIONS:

1. Master's Degree, Michigan Teaching Certificate and four (4) hours of college preparation in School Administration or Curriculum, or equivalent.
2. Minimum of five (5) years of successful teaching preferred secondary experience.
3. Demonstrated leadership qualities (over a significant period of time) especially with adult learners.
4. Such alternatives to the above qualifications as the Taylor School District may find appropriate and acceptable.

DUTIES, RESPONSIBILITIES AND EXPECTATIONS:

Under the supervision of the Assistant Superintendent of Curriculum, the School Improvement Coordinator – will have the following duties and responsibilities:

1. State and Federal Programs: Assist in the development, implementation and evaluation of School and District improvement plans
2. Coordinator for District Teams, such as PreK-12, ECT/SCT, ICC, DSSC-Provide support for team in the development of curriculum, instructional strategies and assessment; recruit members, plan meetings, set agendas, publish minutes
3. Professional Development for all content areas
4. Coordinator, writer and editor for new grant opportunities
5. Professional Coach Pre-K for Train the Trainor Model
6. Provide leadership to all stakeholders District and State assessment
7. Align all programs K-12 in regards to District and State assessment
8. Coordinate the annual report data for the District and K-12 buildings
9. Plan and monitor a budget for each area of responsibility

10. Evaluate and inventory curriculum and testing materials
11. Keep abreast of current best practices and research in the area of responsibility and staff development. Approaches include workshops, conferences, seminars, professional memberships and etc.
12. Provide reports on a regular basis to the Board of Education, Central Office, District School Improvement Team and all other curriculum teams
13. Assignments and Special Projects as assigned
