Associates degree, but Bachelor's degree preferred in Criminal Justice, Law Enforcement, Fire Science, Emergency Management, or a closely related field.

Minimum of 4,000 hours of verified, recent, and relevant work experience in public safety, law enforcement, corrections, emergency services, fire service, or a related protective services occupation.

#### **Preferred Qualifications**:

Related Industry Certifications beneficial such as Law Enforcement Officer certification (MCOLES or equivalent), Firefighter I/II certification, or EMT or First Responder certification

Prior teaching or training experience (secondary, postsecondary, or professional development).

Experience with work-based learning, student organizations, or student leadership activities. Familiarity with safety protocols, scenario-based instruction, and CTE reporting requirements related to 43.0100, Public Safety/Protective Services.
