JOB DESCRIPTION

QUALIFICATIONS:

- (1) Minimum of two (2) years verified experience as a skilled plumber or completion of a trade school or equivalent.
- (2) Possess a high school diploma, GED or equivalent if education from a country outside the United States.
- (3) Valid Florida driver's license.
- (4) Satisfactory criminal background check and drug screening.

KNOWLEDGE, SKILLS AND ABILITIES:

Ability to follow oral and written instructions. Ability to read and interpret specifications, drawings, schematics and plans. Knowledge of trade methods, work, materials, tools and equipment. Ability to communicate orally and in writing. Ability to plan, organize and establish priorities related to assignment. Ability to handle sensitive information in a confidential manner. Ability to work independently and make decisions with minimum supervision. Ability to handle multiple tasks in a professional and courteous manner. Ability to answer a telephone in a professional and courteous manner. Ability to work cooperatively with others.

- * (4) Set-up and maintain preventive maintenance program relating to plumbing.

- * (7) Meet and deal effectively with the general public, staff members, parents, administrators and other contact persons using tact and good judgment.
- * (8) Follow attendance, punctuality and other qualities of an appropriate work ethic.

- * (10) Maintain confidentiality regarding school/workplace matters.
- * (11) Model and maintain high ethical standards.
- * (12) Maintain expertise in assigned area to fulfill position goals and objectives.
- * (13) Participate successfully in the training programs offered to increase skill and proficiency related to assignment.
- * (14) Demonstrate initiative in the performance of assigned responsibilities.

*Essential Performance Responsibilities

PHYSICAL REQUIREMENTS:

Heavy Work: Exerting up to 100 pounds of force occasionally, and/or up to 50 pounds of force frequently and/or up to 20 pounds of force as needed to move objects.

A typical day's activities include standing, walking, bending, climbing, stooping, pushing, pulling, lifting, stretching, twisting, reaching and sitting for limited periods only; normal finger dexterity,

visual acuity (with or without corrective glasses), hearing, talking, and firm grasping are also required to carry out essential functions.
