## School Mission:

## Special Education Teacher (K-8)(Part-time - .51FTE)

FCA Special Education teachers will inspire and prepare students for a future success through:

- Employing special education strategies and techniques during instruction to improve the development of sensory and perceptual motor skills, language, cognition and memory.
- Teaching socially acceptable behavior, employing techniques such as behavior modification and positive reinforcement.
- Modifying the general education curriculum for special-needs students based upon a variety of instructional techniques and technologies.
- Conferencing with parents, administrators, testing specialists, social workers, and professionals to develop individual educational plans designed to promote each student's educational, physical and social development.
- Meeting with parents and/or guardians to discuss their children's progress, and to determine their priorities for their children and their resource needs.
- Supporting children's emotional and social development, encouraging understanding of others and a positive self-image.
- Experience administering academic achievement assessments (WIAT-III, KTEA-3, WRAT-5, etc).
- Coordinating interpretation and transcription of regular classroom materials through Braille and sign language as needed.
- Consult with other school staff as necessary to complete the functions of the position.
- Complete written reports and assigned administrative tasks related to these functions, such as student's progress in educational, physical and social development.

- **Education:** Master's Degree in Special Education
- **Experience:** 3+ Years in special education instruction, including coteaching experience.
- **Knowledge, Ability & Skills:** Strong oral, written and interpersonal skills; ability to perform independently. Ability to remain pleasant and helpful under sometimes-stressful circumstances. Excellent organizational skills and the ability to prioritize and multitask when necessary. Knowledge of applicable federal and state regulations and statutes and theory and practice of student learning styles. Ability to communicate cooperatively and constructively with other staff, students and parents in a multi-cultural environment.

Firestone Charter Academy prioritizes our employee's health and well-being. As part of that priority, we offer a choice of Employee Benefit plans, Employee Assistance Plans, and access to wellness programming through our benefit providers.

All positions are eligible for PERA (pension) and several Employee Assistance Programs (EAP) offered by our providers.

**WORK ENVIRONMENT** While performing the duties of this job, the employee may be exposed to moving mechanical parts associated with wheelchairs and/or other adapted equipment. The noise level in the work environment is usually moderate to loud.

**MENTAL FUNCTIONS** The employee will be required to be able to apply principles of logical or scientific thinking to define problems, collect data, establish facts, and draw valid conclusions; to interpret an extensive variety of technical instructions in mathematical or diagrammatic form; and to deal with several abstract and concrete variables.
