#### **POSITION SUMMARY/PURPOSE**

Under the general supervision of the School Principal, to develop and implement instructional programs to promote the awareness of the importance of a positive home and family living environment; to motivate each pupil to acquire competencies, knowledge, and skills relating to child development, consumer education, food consumption and nutrition, home healthcare and safety, and household equipment.

## **ESSENTIAL PERFORMANCE RESPONSIBILITIES:**

- Develops and administers consumer science education curriculum consistent with school district goals and objectives.
- Promotes a classroom environment that is safe and conducive to individualized and small group instruction, and student learning.
- Develops lesson plans and instructional materials and translates lesson plans into learning experiences so as to best utilize the available time for instruction
- Teaches knowledge and skills in one or more of the following subjects to secondary pupils: typing, note-taking, bookkeeping, record-keeping, office procedures, business communications, data processing or basic business principles.
- Prepares appropriate instructional aids and display materials to enhance learning.
- Instructs students and demonstrates skill techniques in the use, care, and safe operation of household equipment and appliances.
- Conducts ongoing assessment of student learning, and modifies instructional methods to fit individual student's needs, including students with special needs.
- Continues to acquire professional knowledge and learn of current developments in the educational field by attending seminars, workshops or professional meetings, or by conducting research, and by maintaining professional relationships with members of the business community.
- Organizes and maintains a system for accurate and complete recordkeeping, grading, and reporting for all student activities, achievement and attendance as required by district procedures and applicable laws.

## **ESSENTIAL PERFORMANCE RESPONSIBILITIES (continued):**

- Encourages parental involvement in students' consumer science education and ensures effective communication with students and parents.
- Maintains current vocational information for students interested in careers in teaching or consumer science.
- Ensures that student conduct conforms with the school's standards and school district policies, and establishes and maintains standards of pupil behavior needed to achieve a functional learning atmosphere in the classroom.
- Coordinates with other professional staff members, especially within grade level, and participates in faculty meetings and committees.
- Selects and requisitions appropriate books, instructional aids and other supplies and equipment and maintains inventory records.

#### **ADDITIONAL DUTIES:**

Performs other related tasks as assigned by the Principal and other central
office administrators as designated by the Superintendent.
