JOB SUMMARY: Under general supervision, a school nutrition assistant will prepare and serve nutritional meals for school aged children meeting the reimbursable meal requirements per the federal guidelines.

4.	Cleaning all dishes, work stations, cooking equipment, and food storage areas in accordance with food safety regulations.
5.	Reports all damaged or faulty equipment to the kitchen manager.
6.	Follows established storage of ingredients to ensure compliance to food safety regulations.
