Job Summary:

The ALC offers a multi purpose childcare center for adolescent parents and community members and is currently a partnership with Early Head Start (EHS). The childcare lead is responsible for maintaining a healthy and safe environment for the children in compliance with state licensing requirements and establishing and maintaining supportive relationships with their parents. The childcare lead will perform the daily tasks of nurturing and caring for the children in the childcare setting and providing opportunities for the parents to participate in parent-child activities under the supervision of the Childcare supervisor. Under the direction of the Childcare Supervisor, the childcare lead will implement the Creative Curriculum for infants and toddlers and complete the TS Gold assessments on EHS eligible children. Childcare staff will participate in monthly parent engagement activities as directed by the childcare supervisor.
