### Summary:

Assist driver and students while they are being transported to and from school; and provide discipline and guidance to the students while they are on the bus.

## Minimum Requirements:

**Knowledge** (position requirements at entry)

- ✓ Approved procedures/techniques involved in supervising students;
- ✓ Safety procedures and guidelines;
- ✓ Department and district policies;
- ✓ First Aid and Cardio Pulmonary Resuscitation (CPR).

Skills (position requirements at entry) "

- ✓ Applying First Aid and Cardio Pulmonary Resuscitation techniques;
- ✓ Ability to assist in lifting students and operate the wheelchair lift;
- ✓ Monitoring and disciplining children;
- ✓ Providing and maintaining a safe atmosphere on bus;
- ✓ Performing emergency evacuations:
- ✓ Communication, interpersonal skills as applied to interaction with coworkers, supervisor, the general public, etc. sufficient to exchange or convey information and to receive work direction.

### Training and Experience (position requirements at entry)

- ✓ High School Diploma or G.E.D.;
- ✓ Knowledge of and ability to assist students with various special needs and related equipment;
- ✓ Or any combination of education and experience sufficient to successfully perform the essential duties of the job such as those listed above.

# Licensing Requirements (position requirements at entry)

- ✓ Appropriate commercial driver's license and state bus driver's certificate.
- ✓ Current First Aid and CPR Certifications.

- Transports children safely and timely to and from school
- Monitors children and maintains discipline when students are on bus.

- Assist the driver in securing wheelchairs, student restraints, and other safety equipment on the bus.
- Performs First Aid and CPR procedures, if necessary.
- Provide specified medical support for students on board the bus.
- Assist driver in conducting emergency evacuations.
- Performs other duties of a similar nature or level.

# Physical Requirements:

- Positions in this class typically require: climbing, balancing, stooping, kneeling, crouching, reaching, standing, walking, pushing, pulling, lifting, grasping, talking, hearing, seeing, and repetitive motions.
- Incumbents may be subjected to vibrations, fumes, odors, extreme temperatures, intense noises, and travel.
- Exerting up to 100 pounds of force occasionally and/or a negligible amount of force frequently or constantly to lift, carry, push, pull or otherwise move objects, including the human body.
- Sedentary work involves sitting most of the time.
  Jobs are sedentary if working and standing are required only occasionally and all other sedentary criteria are met.
